Implications:

Risk:

The intention of this decision is to comply with legislation and therefore avoid the risk of non-compliance.

Value for Money:

The on-street parking service is not designed to produce surplus income, but, in line with government guidelines, to be self-financing.

The consultants selected for this function have previously carried out consultations and design works in the Borough and is familiar with the area. They are also one of the named contractors in the framework agreement for the provision of consultancy for traffic related operations and parking with Watford Borough Council which is available to the three district councils that work within the parking enforcement partnership.

The cost of introducing this scheme is estimated to be £5,000, which will be met from within existing resources.

Options Considered and reasons for rejection:

BACKGROUND

Northchurch Parish Council has called for the bays outside the district shopping centre in Northchurch High Street South to have a limited wait restriction placed on them to allow access to local amenities. Currently bays are often occupied for long periods which impacts on parking availability for potential users of the amenities.

There are two disabled persons' bays in this area which are currently unenforceable and often misused by able bodied drivers.

There is currently no junction protection to the northeast of the shopping parade which results in drivers parking inappropriately on the pavement. It is therefore proposed to introduce no waiting at any time restrictions to avoid danger to pedestrians and other traffic using the road and pavement.

The intention of the consultation is to determine the support for proposals to introduce limited wait bays to make the disabled persons' bays enforceable and to introduce no waiting at any time restrictions to the northeast of the shopping parade.
